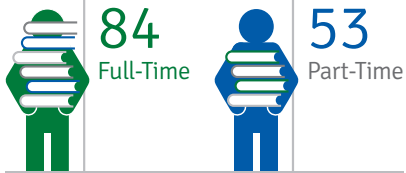

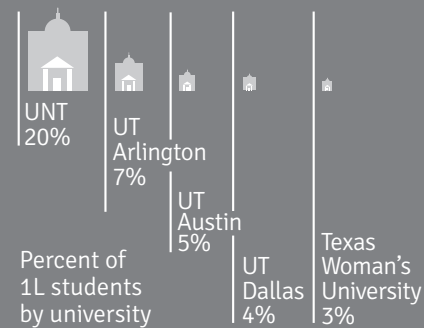

Provisional accreditation may be granted during a school's third year of operation. A student who graduates from a provisionally approved law school is entitled to the same recognition given to students and graduates of fully approved law schools. The College of Law—including the Dean and its administration—is fully informed as to the ABA's Standards and Rules of Procedure for the approval of Law Schools. We are determined to devote all necessary resources and to take all necessary steps to provide a program of legal education that will qualify for approval by the American Bar Association. The College of Law does not make any representation to any applicant that it will be approved by the ABA before the graduation of any matriculating student.
