Payment Deadlines: Full payment of tuition and fees are required upon registration or by the payment deadlines listed below.

Payment for any additional tuition and fees resulting from Schedule Revision or Add/Drops is due by Census Day for the term.

UNT Dallas provides the following alternatives for the payment of tuition and fees:

Regular Registration Payment Deadline (Full and 1st 8 Week) ...Tuesday, January 15

Late Registration Payment Deadline (Full) Wednesday, January 16

Regular Registration Payment Deadline (2nd 8 Week) Monday, March 19

Installment Payment Plan

Refund Schedule

Refunds for dropping or withdrawing from UNT Dallas will be generated once classes begin. The amount depends on whether or not you remain enrolled in other courses. The refund policy is based on Texas state law and can be found under *Section 54.006* of the Education code of the Texas Statutes.

Dropping a Course(s)

If you drop a course(s) but remain in at least one other course, you will receive a 100% refund until the following date:

Full Term Session Wednesday, January 30

8 Week 1 Session Tuesday, January 22

8 Week 2 Session..... Monday, March 25

Complete Withdrawal – TENTATIVE DATES

If you drop or withdraw from all your courses for the semester, the following refund schedule applies to you:
